Terms and Conditions

Digi, Belize Telemedia Limited (“BTL”) will be hosting a Christmas Raffle (the “Raffle”) for a period of 5 weeks starting Wednesday, November 14th, 2018 and ending on Monday, December 24th, 2018 at 12p.m.(“Promotion Period”), opened to all existing and new Digi customers, customers who participate in the Make the Switch Promotions and new DigiNet sign up customers.

PRIZES

1. The prizes for the Raffle are as follows:

REQUIREMENTS:

2. To qualify for an entry in the Raffle customers must meet the below entry criteria:
 - a. DigiCell PrePaid customers will receive a single entry for every \$10 spent using their primary balance to make calls, send texts or to purchase data during the Promotion Period. This \$10 can be accumulated using all three services within the Promotion Period.
 - b. PostPaid Mobile, Internet and Home Phone customers will receive an automatic entry if their monthly bills are paid in full on or before the due date for their respective cycles. These customers will receive a single entry for every \$10 paid for their monthly bill during the Promotion Period.
 - c. All new mobile Customers that Make the Switch will receive an automatic entry into the Raffle.
 - d. All customers who purchase a Krismus device from Digi will receive an automatic entry into the Raffle.

- e. Every new DigiNet customer to be installed during the promotion period.

GENERAL TERMS AND CONDITIONS:

3. A customer is eligible to win ONLY ONCE for the duration of the Promotion Period and also only once to qualify for the grand prize.
4. All qualifying entries will be randomly selected using an electronic random selection system. The selection process will be supervised by Digi's Internal Auditors.
5. In office drawings will be hosted live beginning December 1st up to December 24th, 2018. Winners will be contacted by the live Digi Agent and advised of the prize won. Customers will be required to answer the call when Digi Agent is calling to share that he/she has won. If customer does not answer on first call, the Digi Agent can try 2 additional calls. Customer has 3 chances to answer call.
6. Customers must present proper identification to claim prizes. Acceptable identification includes Passport, Social Security card and Driver's License.
7. To qualify, winner must be the person in whose name the winning phone number is registered. Winner must also be in the country at the time of the draw.
8. Any and all uncollected Prize not collected by December 31st, 2018 will remain the property of Digi.
9. On December 24th, 2018 at 1p.m., 3 randomly selected entries will be chosen via an electronic draw based on the transactions for the period November 14th, 2018 to December 24th, 2018, 12p.m.
