

# DIGI DI DRIFT SOCIAL MEDIA LIVE SHOW TERMS AND CONDITIONS

1. The live show (the "Live Show") is open to people aged 18 and over.
  2. Employees of Belize Telemedia Limited ("DIGI", "We") and their family members, may not enter the Live Show.
  3. Entrants into the Live Show shall be deemed to have accepted these Terms and Conditions.
  4. By submitting your personal information, you agree to receive emails from DIGI containing offers and developments that we think may interest you. You will be given the opportunity to unsubscribe to these emails.
  5. **Only one** entry per person. Entries on behalf of another person will not be accepted and joint submissions are not allowed.
  6. DIGI accepts no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason. Proof of delivery of the entry is not proof of receipt by DIGI.
  7. Participants will randomly be picked off the streets at events happening countrywide. They will be asked to answer questions about DigiNet, DigiCell, DigiTel, DigiLearn, DigiWifi, Digi, Krismus Giveaway etc...
