

# **DIGINET HUNT SOCIAL MEDIA CAMPAIGN**

## **TERMS AND CONDITIONS**

1. The prize draw (the "Prize Draw") is open to people aged 15 and over.
2. Employees of Belize Telemedia Limited ("DIGI", "We") and its group companies and their family members, may not enter the Prize Draw.
3. Participants that have won any of our Social Media Competition within the 6 months are not eligible to participate.
4. Entrants into the Prize Draw shall be deemed to have accepted these Terms and Conditions.
5. By submitting your personal information, you agree to receive emails from DIGI containing offers and developments that we think may interest you. You will be given the opportunity to unsubscribe to these emails.
6. To enter the Prize Draw you must upload your completed collage on Facebook of all the 10 DigiNet items. Must use hashtags #DigiNet #FastInternetinBelize and be sure to like Digi FB Page.
7. **Only one** entry per person. Entries on behalf of another person will not be accepted and joint submissions are not allowed.
8. DIGI accepts no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason. Proof of delivery of the entry is not proof of receipt by DIGI.
9. The closing date for submission of posts is **23:59 on 16 October 2019**. Entries received outside this time period will not be considered.
10. Ten winners will be chosen based on the criteria formed by Digi in accordance with these Terms and Conditions. **The selection of winners will be done by a panel of judges from Digi. Participants will have a total of 10 days to search for the items, create a collage and post on the FB wall.**
11. DIGI accepts no responsibility for any costs associated with the prize and not specifically included in the prize (including, without limitation, travel to and from our offices to collect the prizes).
12. **The winner will be notified by phone/email / text and must come to the Digi office in person to claim prize.** If a winner does not respond to DIGI within 7 days of being notified by DIGI, then the winner's prize will be forfeited and DIGI shall be entitled to select another winner in accordance with the process described above (and that winner will have to respond to notification of their win within 7 days or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited and DIGI shall be entitled to select another winner.

13. The prize is non-exchangeable, non-transferable, and is not redeemable for cash or other prizes.
14. DIGI retains the right to substitute the prize with another prize of similar value in the event the original prize offered is not available and reserves the right to change the rules which will be shared with the participants on FB.

16. DIGI shall use and take care of any personal information you supply to it as described in its privacy policy, a copy of which can be seen here, and in accordance with data protection legislation. DIGI further disclaims liability for any injury or damage to your or any other person's computer or mobile device relating to or resulting from participation in or downloading any materials in connection with the Prize Draw. Nothing in these Terms and Conditions shall exclude the liability of DIGI for death, personal injury, fraud or fraudulent misrepresentation as a result of its negligence.

DIGI reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, this Prize Draw with or without prior notice due to reasons outside its control (including, without limitation, in the case of anticipated, suspected or actual fraud). The decision of DIGI in all matters under its control is final and binding and no correspondence will be entered into.
19. DIGI shall not be liable for any failure to comply with its obligations where the failure is caused by something outside its reasonable control. Such circumstances shall include, but not be limited to, weather conditions, fire, flood, hurricane, strike, industrial dispute, war, hostilities, political unrest, riots, civil commotion, inevitable accidents, supervening legislation or any other circumstances amounting to force majeure.
20. DIGI reserves the right to immediately disqualify any participants suspected of photoshopping images. All images should be of participant and items and must be clearly shown.
21. The Prize Draw will be governed by Belize Law and entrants to the Prize Draw submit to the exclusive jurisdiction of the Belize courts.
